STATE WIDE COLLABORATION

There are three Membership categories for the Nebraska Coalition.

1. Direct Service Domestic and Sexual Violence Programs

This category consists of the established network of programs providing direct services to victims of domestic and sexual violence, as well as centering prevention efforts in communities.

- The established member programs meet requirements as defined by Nebraska's Protection from Domestic Abuse Act (Neb. Rev. Stat. 42-901 et seq.), and match the criteria listed in the Nebraska Confidential Communications Statute. (Neb. Rev. Stat. 29-4302et seq.).
- The programs also provide the services for victims of family violence, domestic violence, and dating violence as outlined in the Family Violence Prevention and Services Act. (42 USC 10406 10408).
- Each program in the established network meets the Program Standards as created by the Nebraska Coalition, the network of programs, and Nebraska Department of Health and Human Services.

2. Affiliates

This category consists of organizations that assist victims directly or indirectly and/or are working to reduce domestic and sexual violence.

3. Individuals

This category consists of individuals who wish to be active in the movement to end domestic and sexual violence.

MEMBERSHIP PROCESS

The Nebraska Coalition actively values all who are engaged in our work, and we welcome diversity to our membership. We choose to intentionally build a membership that includes multiple identities, and embraces all lived experiences. We strive to create inclusive and anti-oppressive practices.

Applications for membership shall be submitted to the Executive Director of the Nebraska Coalition, and will be reviewed by the Board of Directors. Applicants may be interviewed by board members, and input may be sought from the local domestic/sexual violence program that serves the area in which the applicant is located.

Approval or denial of membership is by a majority vote of the Board of Directors of the Nebraska Coalition, and the applicant will be notified in writing.

Applicants that are approved will become a member upon receipt of their annual dues, which are non-refundable. The term of membership may be renewed annually upon payment of dues.

Members who do not uphold the mission, vision, values, or philosophy of the Nebraska Coalition, or who misrepresent or denigrate the organization, may be brought before the Board of Directors for removal from membership by a majority vote.

A member organization may resign from membership by submitting a written resignation to the Executive Director of the Nebraska Coalition.
