The providers featured in the directory were gathered from listings found on statewide service agency and government websites, listings found on the websites of national networks, and a survey distributed to members of the NebraskaPATH listserv in Spring of 2021. While the intent of the directory is to provide a thorough listing of services available to human trafficking survivors in Nebraska, the directory is not exhaustive.

Please use the directory as a starting point for learning about the anti-trafficking service providers in your community. NebraskaPATH does not endorse any particular service provider. Inclusion in this list is not a guarantee of service availability. If you are planning to refer a survivor to a particular service provider, it is recommended that you reach out to the service provider first to verify that they are appropriate to meet the needs of the survivor.

Prior to working with survivors of human trafficking, it is essential that you familiarize yourself with the qualities of a trauma-informed service provider. **NebraskaPATH has compiled a list of qualities that a trauma-informed service provider displays:** <u>Standards of Practice to Support Victims/Survivors of Trafficking.</u>

The Purpose of NebraskaPATH

NebraskaPATH facilitates connection between those involved in the anti-trafficking movement to build a competent, trauma-responsive, and survivor-centered response to human trafficking in Nebraska.

NebraskaPATH Values

NebraskaPATH values collaboration, shared learning, and mutual accountability and support among those involved in the anti-trafficking movement in our state.

NebraskaPATH is committed to being survivor-driven and survivor-centered.

NebraskaPATH understands that human trafficking is a symptom of the oppression and inequity present in our state and society.

How NebraskaPATH Promotes These Values

To promote the development of services for survivors of human trafficking that are aligned with NebraskaPATH's values and the "Standards of Practice to Support Victims/Survivors of Trafficking", NebraskaPATH currently engages in the following activities:

- Hosts monthly Community Case Staffing meetings open to all members of the anti-trafficking movement in Nebraska.
- Hosts quarterly Community Update meetings open to all members of the anti-trafficking movement in Nebraska
- Maintains an email listsery open to all members of the anti-trafficking movement in Nebraska
- Distributes a quarterly newsletter featuring updates about anti-trafficking efforts
- Promotes best and promising practices related to anti-trafficking efforts

The NebraskaPATH listserv, community update, and creative case staffing meetings are open to all involved in anti-trafficking work in Nebraska. We hope to continue to grow and strengthen this network to provide competent, trauma-responsive, and survivor-centered support.

NebraskaPATH History and Organization

Beginning in 2019, several organizations and individuals who participated in the Services Subcommittee of the Nebraska Human Trafficking Task Force (NHTTF), came together to talk about how collaboration and coordination around services and support for survivors of trafficking could best continue due to a federal grant, which had been supporting statewide anti-trafficking work, ending.

Gathering input from partners across Nebraska, this initial group decided to create a statewide listserv and begin to engage in activities to promote communication and information sharing across a loose network of those involved in the anti-trafficking field. As the organizing leadership received feedback and shifted its work to adapt to the COVID-19 pandemic, NebraskaPATH's organizing team began offering monthly virtual statewide meetings and having structured conversations about the future of NebraskaPATH.

Current Organizing Leadership of NebraskaPATH

Currently, the Women's Fund of Omaha, Women's Center for Advancement, Rachel Pointer Coaching & Consulting, Thriving Warrior, the Nebraska Alliance of Child Advocacy Centers, the Nebraska Coalition to End Sexual and Domestic Violence, Heartland Housing Sanctuary, and Ponca Tribe of Nebraska organize the work of NebraskaPATH.

Mandatory Reporting of Child Abuse and Neglect:

In the state of Nebraska, **everyone** has a responsibility to report child abuse or neglect. State law requires any person who has a reason to believe that a child has been abused or neglected to report their concerns to the Child Abuse and Neglect Hotline.

Your contact with the hotline is confidential and will not be shared with the family. You may be contacted by a Child and Family Services Specialist during the investigation, however, you may request to remain anonymous.

Who is considered a vulnerable adult? Persons who are:

- 18 years of age or older and have a substantial functional or mental impairment (a condition that impairs a person's ability to live independently or provide self-care without services) OR
- 18 years of age or older and have a guardian that was appointed by the Nebraska Probate Code AND
- There are allegations of abuse, neglect, or exploitation, including self-neglect.

Sexual Assault Nurse Examiner (SANE) Programs in Nebraska

A Sexual Assault Nurse Examiner (SANE) is a registered nurse who completed additional education and training to provide comprehensive health care to survivors of sexual assault and collect forensic evidence.

A sexual assault forensic exam is conducted by a SANE to collect DNA and other evidence from the survivor's body, clothes, and other personal belongings after a sexual assault. This allows the survivor to safely store DNA and other evidence, which may be beneficial should the survivor choose to pursue legal action against the perpetrator. The exam also includes additional medical care and treatment for the victim, such as care for sexually transmitted infections, emergency contraception for pregnancy, and follow-up resources. There is the potential for evidence collection up to 120 hours after a sexual assault. Generally, the less time that has elapsed between the assault and the forensic examination, the greater the potential to collect evidence. Sexual assault survivors are encouraged to seek medical attention even if it has been greater than 120 hours since the assault.

College/University Support Services

Colleges and universities have the capability to connect students experiencing intimate partner violence, sexual assault, stalking, or human trafficking to support services, whether provided through a counseling/victim advocacy program at the institution or a community partner. This information can be found on the college/university's website and is listed in the institution's annual security report (also known as a "Clery" report).

Students attending educational institutions that receive federal financial assistance from the Department of Education are protected from gender-based discrimination, including sexual harassment and sexual assault, under Title IX of the Education Amendments of 1972. Most K-12 schools and postsecondary institutions are required to comply with Title IX.

To find out the reporting options available at your institution to students, staff, and faculty who have witnessed or experienced gender discrimination, search for information on the "Title IX Coordinator". This information is also detailed in the institution's annual security report (also know as the "Clery" report).

Title X Providers

Title X is the sole federal program dedicated to providing comprehensive family planning and preventative health services. These services include contraception, pregnancy testing and counseling, preconception health care, STI/HIV screening and treatment, breast and pelvic exams, breast and cervical cancer screenings, and basic infertility services. In Nebraska, 11 agencies receive Title X funding to provide these services throughout the state.

Services at a Title X-funded clinic are free or low-cost. Everything shared by a patient during a visit is private and confidential, except in cases where abuse is suspected. Healthcare providers are required to contact law enforcement when they receive a report of abuse. Abuse includes physical abuse, incest, rape, sexual abuse of a minor, etc. Services are provided to individuals of all ages (apart from a few teen and young adult-specific clinics) and gender identities. Teens are encouraged to bring or talk to their parents, but parental involvement isn't required to be seen at a Title X clinic.
