
Network of Domestic Violence/Sexual Assault Programs

There also are 4 tribal domestic violence/sexual assault programs in Nebraska, serving the Ponca, Winnebago, Omaha and Santee Sioux nations.

Network Services

The network of domestic violence/sexual assault programs offer a range of services for both adults and children who are victims of domestic and sexual violence. Each program provides the following seven core services. Supplemental services vary in each area.

24 Hour Crisis Line

Confidential support, information and access to services are available 24 hours a day by calling the program in your area.

Legal Referrals and Assistance with Protection Orders

Programs cannot give legal advice; however, they can provide assistance with obtaining a domestic abuse protection order, emotional support through court proceedings, and referrals to local attorneys.

Emergency Shelter

Providing a safe place to stay is an important service of the programs. Using a combination of shelters, hotels and other options, programs offer people a place to escape further violence.

Ongoing Support and Information

Individual ongoing support is provided to survivors. Support groups for survivors of domestic violence and sexual assault are available in many communities. Some programs offer groups for teens experiencing violence, child witnesses, and educational groups for people who batter.

Transportation

Emergency transportation to shelter is available 24 hours a day. Programs also may provide transportation to court proceedings, medical services or to other community agencies.

Education and Prevention Programs

Prevention programs are provided for children, youth and adults on topics such as child sexual abuse, sexual assault, dating violence, stalking, and healthy relationships. Staff and volunteers are available for presentations to community groups and other organizations.

Medical Advocacy and Referrals

Staff and volunteers are available to accompany survivors to hospital emergency rooms and local medical offices for treatment of injuries or an exam after a domestic or sexual assault.

Nebraska's coalition of domestic violence/sexual assault programs provide access to safety and shelter across the state.

2013 - 2014 Network Statistics

The local domestic violence/sexual assault programs strive to meet the needs of victims and survivors and to provide a voice to speak on their behalf when needed. Additionally, programs work to hold perpetrators accountable and implement efforts to prevent domestic and sexual violence.

During October 1, 2013 - September 30, 2014, the local domestic violence/sexual assault programs provided the following services.

People Served

⌘ 22,655 people received direct services

Shelter Services

⌘ 57,485 shelter beds provided
 ⌘ 1,266 adults and 1,306 children and youth received shelter services

Crisis Line Calls

⌘ 43,054 calls to the 24 hour crisis lines operated by the network of programs

Supportive Counseling and Advocacy

When reporting statistics, programs had the option of including either the number of contacts or the number of hours. Therefore, the number of contacts does not include the number of hours listed.



*This report includes the statistics provided to the Nebraska Coalition to End Sexual and Domestic Violence by the local domestic violence/sexual assault programs. These numbers reflect only the services provided by the programs. They do not include services provided to victims/survivors by other agencies (i.e., police, medical). Therefore, this information should be seen as a conservative estimate. The actual number of victims, survivors, and services provided in Nebraska is likely to be much greater.

Prevention/Educational Programs

- ⌘ 2,152 prevention/educational programs were conducted
 - ⌘ 67,329 individuals attended*
- ⌘ An additional 1,762 awareness activities were provided

2014 Direct Services by the Nebraska Coalition

In addition to the direct services provided by the network of programs, the Coalition provided the following direct services between January - December 2014 (the Coalition's fiscal year) through the Immigrant Victims Relief Project.

The Immigrant Victims Relief Project is a joint project between the Coalition and the Center for Legal Immigration Assistance (CLIA). It is funded through the rural grant program, which started on October 1, 2013. The project allowed Coalition attorneys and BIA accredited staff at CLIA to provide legal assistance to victims/survivors with VAWA self-petitions, U visas, T visas, and related filings before the United States Citizenship and Immigration Services (USCIS).

- ⌘ Coalition and CLIA staff provided legal assistance to immigrant victims of violence seeking relief through immigration options provided under the Violence Against Women Act (VAWA) and the William Wilberforce Trafficking Victims Protection Act. Coalition and CLIA staff:
 - ⌘ assisted 56 victims/survivors of violence as primary petitioners; and
 - ⌘ assisted 42 other qualifying family members (qualifying family members include parents, spouses, children under the age of 21, or siblings under the age of 18).
- ⌘ The rural grant also funds the Línea de Crisis, a 24-hour hotline for Spanish speaking victims/survivors of domestic and sexual violence.
 - ⌘ Hotline staff took 47 calls from victims/survivors
 - ⌘ Hotline staff took an additional 30 calls from individuals who were not victims/survivors, such as friends and family members, and from the programs for assistance in interpretation/translation with Spanish speaking clients.

Training, Education, and Technical Assistance to the Network**

- ⌘ Responded to 4,450 telephone/email requests for information
- ⌘ Conducted 22 on-site visits, including 5 peer reviews
- ⌘ Provided 49 trainings, totaling 176.75 hours attended by 597 people



Training, Education, and Technical Assistance to Other Agencies**

- ⌘ Responded to 808 telephone/email requests for information
- ⌘ Provided 36 trainings in multidisciplinary forums, totaling 174.5 hours and attended by 835 people, including:
 - ⌘ 17 statewide or regional trainings/webinars in Nebraska
 - ⌘ Statewide *No More in Nebraska* conference
 - ⌘ 1 training in another state
- ⌘ Convened and/or attended 155 meetings on collaborative initiatives and enhancing services
- ⌘ Reviewed all batterer intervention programs, including 4 in person reviews



Publications and Resources

- ⌘ Shared information and resources through 7,697 mailings to the network of programs and 2,725 mailings to other agencies
- ⌘ Distributed 4 issues of the *No More in Nebraska* newsletter
- ⌘ Distributed 38,176 brochures and other materials



Public Awareness

- ⌘ Attended 4 events sponsored by local organizations

Public Policy

- ⌘ Sponsored a statewide *Legislative Update Day* to inform state senators and other leaders about domestic violence, sexual assault and stalking
- ⌘ Provided analysis of proposed legislation and direct lobbying efforts to advocate for victims



Staff Development and Training

- ⌘ Attended a combined total of 145 state and national teleconferences, webinars, meetings and trainings to keep current about emerging issues

Nebraska Coalition Reveals New Name and Logo

In October, the Coalition officially revealed a new name - the **Nebraska Coalition to End Sexual and Domestic Violence**. Previously the Nebraska Domestic Violence Sexual Assault Coalition, the agency recently embraced the importance of adding action to their name to recognize the ultimate goal of *ending* violence.

With the new name came a new logo (pictured above). The colors of the logo were specifically chosen to represent the three primary areas that embody the work of the Coalition. Purple represents domestic violence awareness, teal symbolizes sexual assault awareness, and orange signifies dating violence awareness.

The three circles not only exemplify these primary areas of our work but they also represent the Coalition, the network of programs across Nebraska, and the victims/survivors whose voices are at the core of our efforts. These three layers of partnership are absolutely vital to our mission.

The logo is organic, inviting and personal, much like our organization. The rings may also create a sense of motion, symbolizing our constant efforts to move forward. The imperfections and varying sizes of the rings represent that each story is unique, and we accept each individual exactly as they are, imperfections and all. We are also able to see the beauty that lies within the flaws. Lastly, the rings overlapped closely together conveys a sense of unity, assurance and comfort to survivors in Nebraska.

The new name and logo were created through discussions among staff, the Board of Directors and the directors of the local domestic violence/sexual assault programs. Several options were presented and evaluated throughout a year long process. The final results were officially unveiled at the awards banquet held October 29 during the *No More in Nebraska* conference.

The Coalition also implemented a new website, www.nebraskacoalition.org. All items from the original website (www.ndvsac.org) are being transferred to the new site.




